#### a) CLLR. S. REYNOLDS:

- There are budget issues. The Council are asking for the public's thoughts. Adult Services have a huge deficit at present. There are plans to re-organise.
- Celtic Leisure may be brought back in house.
- The deregulation of Common Land. East Pit and the Lake have been approved by the Minister and confirmed by the Commoners. There has been lots of planning interest. Foot paths need to be put back in place including bridleways and cycle paths between Tairgwaith and Cwmllynfell.

#### b) CLLR. S. THOMAS:

• Street lights could be turned off between 0100 hrs and 05—hrs. However, this would not be the case where there are issues of safety or crime. Another way to reduce costs could be through reducing brightness to 75% on certain streets. This is currently in proposal stage. This will help reduce the electricity bill.
