Cllr. L. Prescott advised there is a plant known as 'Lady's Smock' growing at GCG Community Centre, this plant is beneficial to biodiversity, Cllr. L. Prescott will install a small barrier around the plant to protect it and ensure it doesn't get damaged during maintenance and grass cutting.

Cllr. L. Prescott notified Council that were was some vandalism to the boundary fence at the front of GCG Community Centre, someone had pulled the fencing off the posts and it was hanging down over the pavement, Caretaker has repaired this with cable ties, this is a secure repair but may be easier to vandalise in future.

Cllr. S. Thomas advised Council that there is some damage to the rendering around the windows at the rear of Tairgwaith Community Centre, this is allowing water to get into the exterior walls and this is doing some damage, it isn't too bad yet but we do need to get this looked at and fixed if we don't want structural and/or damp issues going forwaed.

Cllr. C. Petrie agreed to check and request any payments we need to make until Cllr. D. Jones is available, so that Cllr. S. Thomas can act as a signatory.
