It was reported that the contractor's performance was unacceptable to the Council. He had failed to install the lights until the 15th December, 2018 - this was two weeks later that the 30th November, 2018 agreed at the outset. In addition, the lights were not installed in accordance with the locations agreed with Neath Port Talbot CBC and he had failed to respond to repeated telephone, e-mail and text messages.

This was most unsatisfactory and contrary to the terms of the contract. In the circumstances it was proposed, seconded and agreed by all members present that the contract be severed and that the Christmas Lights 2019 be delegated to a group of councillors – it was agreed that the group include Dafydd, Leander, Mike and Cathryn.
