Budget updates are due. Welsh Government warn there is a huge deficit coming of around \pounds 4 million, possibly double deficit so one-year to be almost double. The Local Authority has been looking for warm-house funding for warm places and food funding. The hardship fund has been open for a while with details on the NPTCBC website.

Locally, flood risks have been an issue and sandbags have been delivered to GCG Hall so they are available quickly if needed. Work has been carried out on Maes Y Glyn to stop future flooding.
